In season 2022 we had 14 winter teams with over 120 registered players across, 14 team Managers with 5 teams making finals, 3 progressing to the grand final and 1 winning the grand final. Whilst winning is enjoyable, the game of netball gives us so much more, including working hard to achieve a goal, being gracious in defeat and humble in victory. Together we grow and develop through netball, reflecting the challenges we face in everyday life giving us the resilience to put one foot in front of the other.

We couldn't have remained so strong without our club sponsors including;

Another wonderful year by Lucy Fiennes as Umpires Convenor continuing to develop our emerging umpires progress through the national badges and introduce an attractive remuneration program to retain and develop young umpires.

Thank you to Luke Houghton as Treasurer for stepping into the role when we had a vacancy and has ensured we have the appropriate oversight across the financials. Once again Serena Artindale delivered the role of Registrar without fuss or fanfare but delivering a great outcome.

Finally, after three years as President it's my time to pass on the baton proud that we have made progress across several areas including;

- Developing and implementing a strategic plan to secure the long-term future of the club

- Shifted the club on google platform to access the full suite of tools for not-for-profit clubs
- Formerly incorporated the club [Wahroonga Netball Club Incorporated]
- Registered with the Australian Sports Foundation securing over \$2,175.00 of new revenue [tax deductible]
- Introduced coaching and skills sessions for junior players
- Invested in First Nations design and artwork for use across all apparel and digital assets
- Updated the players uniform with new dress and indigenous design
- Updated policies including awarding life memberships, grading policy and issue resolution
- Secured new sponsors with over \$5,000 in annual revenue
- Continued to trade with cash reserves of over \$30,000 to mitigate any financial shock and invest in the players, coaches and volunteers to enhance the experience.

### PURPOSE

This update advises members of the club's intent to facilitate a merger that retains and respects the Warrawee Wildcats history and tradition whilst coming together with Wahroonga Netball Club to create a stronger and sustainable club.

#### BACKGROUND

Warrawee Netball Club approached the Wahroonga Netball Club with a proposed merger. Warrawee had 10+ teams 5 years ago and now have 2 teams although financial and with a strong committee having only two teams makes it difficult. Warrawee would like to include/incorporate the Wildcats name and logo, retain existing teams together in the transition year of 2023 and subsidise 2023 fees for the transitioning players.

#### **NEXT STEPS**

Further discussion over the coming months including mascot, committee positions, registration fees and transfer of funds.

In accordance with the constitution the calling of a special general meeting including a notice of motion (14 days prior) to be voted on by a quorum of members.

Once approved formally advising KNA with a notice of motion from both Warrawee Netball Club and Wahroonga Netball Club.
